

Peter Carey - Acting Chief Operating Officer, NeighborWorks® America

Peter oversees field operations, national initiatives, information management and the NeighborWorks Services Group. He joins NeighborWorks America after serving for 25 years as President and CEO of Self-Help Enterprises, a NeighborWorks network organization serving the San Joaquin Valley in California. Peter has been involved in rural development work since 1969 and has received national recognition for his work in support of rural housing including the Housing Assistance Council's Clay Cochran Award for Distinguished Service in Housing for the Rural Poor and LISC's Mike Sviridoff National Leadership Award. Earlier this year, he received National NeighborWorks Association's Richard H. Stallings Lifetime Achievement Award. Carey is past president of the

National Rural Housing Coalition, California Coalition for Rural Housing and the National Rural Self-Help Housing Association. He is also a board member for the National NeighborWorks Association and the Housing Assistance Council and sits on the board of governors for the California Housing Consortium and the NeighborWorks Rural Advisory Council.

PLENARY SPEAKERS



Gayle Conelly Manchin

Gayle graduated from West Virginia University, with a Bachelor of Arts in Language Arts & Education and a Master of Arts in Reading. She also holds a second master's specialization in Educational Technology Leadership from Salem International University. While First Lady of West Virginia, she was appointed by the Governor to serve as a member of the State Board of Education, where she now serves as President. She is the Board Chair for Reconnecting McDowell, an American Federation of Teachers initiative serving rural WV, is a past president of the Vandalia Rotary Club of Charleston, and currently serves on the Clay Center Advisory Board. In addition, she is on the Board of Directors for MVB Bank. Nationally, Gayle is a Past-President of the National

State Boards of Education (NASBE). She was appointed by Sec. of Education, Arne Duncan to the FIPSE (Fed. Improvement for Post-Secondary Education). She also serves on the Board for Horton's Kids, a non-profit organization serving at-risk youth in Washington.



David Zuckerman - Research Associate, The Democracy Collaborative

David Zuckerman joined The Democracy Collaborative as a research associate in 2012. Zuckerman is the author of Hospitals Building Healthier Communities: Embracing the Anchor Mission. As a researcher, his work primarily focuses on community economic development strategies that build wealth in low-income communities, with a specific focus on how hospitals and health systems can better support their surrounding communities. Zuckerman has also assisted with multiple feasibility studies of anchor-led economic development projects. He currently serves on the Board of Representatives for the Takoma Park-Silver Spring Co-op. He received both his Master of Public Policy and B.A. degree in Government and Politics from the University of Maryland, College Park.



Erica Boggess Acting Executive Director - West Virginia Housing Development Fund

Ms. Boggess joined the Fund in 1986, serving in various accounting and finance positions. She was appointed Deputy Director in January 2005. Prior to joining the Fund, she worked in public accounting. Ms. Boggess is a graduate of Marshall University and is a Certified Public Accountant.

J. Michael Hawkins, PhD, AICP Managing Director of Community Outreach - Virginia Housing Development Authority

Mike directs a division comprised of experienced housing and marketing professionals engaged in efforts to build the capacity of housing developers in promoting affordable housing in the context of sustainable communities. He was the Community Development Director for the Newport News Redevelopment and Housing Authority 2000-2005 and the Chesapeake Redevelopment and Housing Authority 1998-2000, directing major neighborhood revitalization efforts in those two cities. Mike is a member of the American Institute of Certified Planners. He holds a Ph.D. in Public Administration & Urban Policy from Old Dominion University.

Ralph Perrey Executive Director - Tennessee Housing Development Authority

Mr. Perry was appointed by the Board of Directors in September 2012; he came to THDA from Fannie Mae, where held a number of positions including director of the Tennessee Community Business Center, coordinator of the company's Central Appalachian Initiative, and national co-lead of the Public Entities Loan Team. Prior to joining Fannie Mae in 2000 he served on the senior staff of former Tennessee Governor Don Sundquist, and served on the THDA Board three times.

Kathy Peters Executive Director - Kentucky Housing Corporation

Ms. Peters was named to her current position at KHC in December of 2013. Kathy joined KHC in 1987 as resource development manager. She was named director of The Housing Foundation when it was created in 1989 as a non-profit subsidiary of KHC. Before joining KHC, Kathy spent 14 years in various management positions with Kentucky state government. She is a graduate of Georgetown College and holds a master's degree in public administration from Kentucky State University.
