# **Kentucky** Seth Long

Seth Long- has served as the Executive Director of Housing Oriented Ministries Established for Service, Inc. (HOMES, Inc.) in Letcher County, Kentucky since 2008. Seth and his wife, Sheryl, hail from southeastern Pennsylvania. In 1991, Seth was working for a custom home builder when he and his wife decided to come to Kentucky for a three month volunteer service position with SWAP, the Mennonite Central Committee (MCC) housing repair program, which was at that time located in Letcher and Harlan County. With a sense of calling and purpose they never left Letcher County.

In the fall of 1991-1995 Seth worked for HOMES, Inc. as a fulltime volunteer through MCC. In 1995 Seth was hired to manage HOMES, Inc. construction activities as the Field Supervisor. In 2005, he was promoted to Deputy Director. In 2008, HOMES, Inc.'s Executive Director for 17 years resigned unexpectedly when HOMES, Inc. found itself on the edge of a financial catastrophe. Moving quickly, HOMES, Inc.'s Board of Directors placed Seth as the Executive Director with hopes of saving the organization. Under Seth's leadership, HOMES, Inc. was able escape a complete financial crisis, stabilizing then growing the organization in a way that is more self-sufficient and sustainable. Over the last 29 years with HOMES Seth has helped to develop 248 new homebuyer opportunities, complete countless rehabilitation projects and fifty affordable energy efficient rentals.

Seth is committed to thinking about opportunities which focus on housing and the important role that housing plays in a healthy community. This is especially challenging in communities with a broken housing market. Seth has been incorporating social enterprise opportunities to help achieve the mission of HOMES and increase sustainability.

Although HOMES, Inc. occupies a large portion of Seth's time, He with his wife and children own and operate SouthDown Farm where they make their niche product, delicious Kentucky Maple Syrup. They also grow a market garden, participate in local farmer's markets, agritourism events and have a permitted commercial kitchen on their farm where they bake what they grow. Seth is a charter member of the Kentucky Maple Syrup Association currently serving as the President of the KMSA.

A graduate of Morehead State University, Cassie Hudson, began her career serving others first as Program Facilitator for Lee Adjustment Center and then the Coordinator of Drug Free Communities for Owsley County Drug Awareness Council. As the Coordinator for Drug Free Communities, she assisted in the planning and coordination of activities aimed at the prevention of substance abuse and implemented a wide range of behavioral programs. She joined Partnership Housing, Inc. (PHI) as the Executive Director in October of 2012, after having served two years as a board member.

Cassie is experienced in securing and administering multiple federal programs, including HOME, Affordable Housing Trust Fund, Federal Home Loan Bank's Affordable Housing Program, Appalachian Regional Commission Funds, CDBG, USDA Rural Development's (RD) 502 Direct, and RD's Section 504 loans and grants. Under Cassie's leadership, PHI has secured over \$13.5 Million dollars in loan and grant funds from federal and local sources, and has assisted over 330 households through single family and multi-family new construction and a highly successful home repair program.

PHI has received awards that include the Kentucky's Touchstone Energy Cooperative "Most Touchstone Energy Homes (2013)" and "Excellence in Community Housing Development (2014)" from the Jackson Energy Cooperative, the Homeless and Housing Coalition of Kentucky Triple Crown of Excellence Award for Housing (2014), the Kentucky Affordable Housing Conference Innovation Award "Energy Efficiency-Residential (2015)", the Nonprofit Service Award from Kentucky Commission on Community Volunteerism and Service Governor's Service Award (2016) and FAHE's Green Energy Efficiency Champion Award (2018).

During Cassie's tenure, she has been awarded the 2014 Excellence in Entrepreneurship Award for Not-For-Profit Entity from The Center For Rural Development and is certified as a Housing Development Finance Professional from The National Development Council, and a Certified Grants Administrator for the Kentucky Community Development Block Grant (CDBG) Program administered by The Department for Local Government.

Cassie is a lifelong resident of Owsley County, KY where she resides with her husband and three children. While her true passion is housing, during her spare time she enjoys spending time with family and friends, being outdoors and enjoying the sunshine.

Clinch-Powell RC&D Rutledge, TN Executive Director During 30 years of public service with USDA I had the great privilege of working with local leaders to form Clinch-Powell, a regional community development not-for-profit focused on building strong communities, caring for people and protecting natural resources in East Tennessee. After retiring from federal service I stepped into the role of Executive Director in 2011.

Clinch-Powell Council is a well-respected not-for-profit entity with a diversified financial portfolio and workforce to support mission programming with an annual budget of nearly \$6 million. I have extensive experience in grant and project development with more than \$50 million in grant awards that have in turn brought investment into the region of well over \$300 million. Clinch-Powell programming focuses on housing, lending, conservation, ecotourism and building community capacity. Our funding, by design, is as diverse as our programming.

Along the way I was honored to receive the Public Service Award from the USDA Secretary of Agriculture, The Nature Conservancy Conservationist of the Year and the U.S. Forest Service National Crystal Award for Rural Community Action. I have also proudly served as the Fahe TN Caucus Chair.

Serving Appalachia is in my blood. As a little girl, my Granny dragged me to community health meetings, city council meetings, senior citizen meetings and more. As an adult, I recognize that my Granny taught me to "show up". At 14, she raised four siblings after her mother died, took in washing to raise three girls after her husband left her and worked in the mine during WWII. She never held a public office, but she was the voice pushing leaders to incorporate to get flood control, the committee woman who worked hard to bring in a rural health clinic, and the visionary pushing for a community center. She showed up and got things done and without ever saying a word, she showed me how to show up too.

In my life, I have also been a farmer and a military housewife. I have worked in a shirt factory, been a car hop, a secretary, sold magazines and sold plasma in tough times to make ends meet. I married a country boy who pumped gas in Crab Orchard, TN and we served our country in England and New Mexico. We have "fit and fought" and loved our life, our two children and our grandchildren for 43 years. We live in Blaine, TN in a log cabin with our two stray dogs, a house full of shotguns and the mandatory broke down vehicle in our yard. We are proudly Appalachian.

I have been blessed to spend a lifetime working with neighbors and partners to tackle community issues and to share what I have learned with dozens of other nonprofits across the country. I am still learning and excited about what comes next for Clinch-Powell and for Fahe, and I am eager to do what I can to strengthen our network.

In 2015, Sarah began a career in the nonprofit sector through a paid 10-week job placement with Creative Compassion, Inc., where she now resides as its Executive Director since 2017. From: Jim King, President Re: President's report Date: April 9, 2020

COVID-19. The news changes daily and this is obviously an extraordinary event and requires a response that is not ordinary but extraordinary. If this were a natural disaster we would think in waves or phases of response, and in my opinion we are still in phase 1. Meaning we are still assessing damage, and reacting to circumstances.

The priorities that should guide us at this time are:

- Our well-being, are we taking reasonable measures to keep ourselves and others safe.
   Our priority is your organization/ team's well-being.
- Business continuity:
  - The families we are here to serve as well as our members count on us. Members are without much of their funding, need access to advice (programmatic as well as HR) now and for weeks to come.
  - Families are at a huge risk, especially for loans we service as many will have a loss of income.
  - o It is my intention to keep Fahe "open for business", not only for the benefit of our members and families but to keep business flowing.

### What is next?

There are two things that need to be done at the same time. We need to keep attention to the immediate/urgent, and at the same time think about what might need to happen in the future.

Yes, there will be a post virus followed by a severe financial crisis. 2009-2010 was the last crisis and Fahe was prepared, therefore had an incredible impact during the couple of years that followed. There is a current need for interventions with borrowers, mortgage customers, CL borrowers, Member needs, and a federal response of program funding that we will advocate for and compete to receive. We are pouring over the CARES act, SBA PPP program and already looking toward the future for additional stimulus and what agenda would matter to Appalachia.

Since the Annual meeting the Executive office:

- Attended White House ONDCP [Office of National Drug Control Policy]
- Met with officials at FHFA Duty to Serve to advocate for continuance of the DTS directive to the Enterprises as well as release of NAHTF. Successful on both fronts.

- Met with USDA on the CF Relending extension, have cooperation with staff to proceed on the legislative side for the extension.
- Met with SBA officials on programs of possible importance to members.
- Met with Wade Henderson and Center for Responsible lending on CRA.
- Renewed discussion with OFN, Hope and Mary Reynolds Babcock for a dedicated fund for persistent poverty rural.
- We hosted a round table with FHFA, Fannie Mae and Freddie Mac. Presented at the FHFA Duty to Serve listening session.
- Completed the Member/Customer service trainings with staff.
- Took part in the OFN Annual meeting with President Clinton and attended a followup in November at the Clinton Library.
- We hosted a follow-up round table with FHFA, Fannie Mae and Freddie Mac.
- Set expectation for CRM to be researched and implemented in calendar 2020.
- Announced a new name and policy paper for Partners for Rural Transformation.

On my mind (In addition to everything is being affected by COVID-19 and the looming economic fallout):

Top of mind for me starts with our relationships; it's our distinctive competitive advantage. It is something that we are good at, and need to continue to learn as we grow.

### Members:

How we support members and partners at this time is critical to our long-term success and a reflection of our values. Our messaging needs to include responsiveness to the crisis so that we don't appear "tone-deaf". Our productivity and earnings will be affected. And our strategic planning and goals may need to shift to new opportunities in the coming months.

### Productivity and Earning:

Earnings: Our productivity is very solid. Based on the data from thru quarter 2, lending and investing is \$63 million and on track to exceed \$100 million. However with the big setback on the virus both our earnings and impact are under threat. We are going to just deal with it and adapt expectations.

Strategic Plan Progress: We got approval from the board to make a plan to extend the strategic plan for an additional 5 years. We will work on a presentation for the June board meeting. For staff this means we have a "solidness" to the trajectory and scope and an affirmation of the work we have done for the past several years.

### **GRACE**

I know our effort is awesome, but this event is unparalleled so we need to be gracious with ourselves as well as extending grace to each other. We are doing the best we know how. I'm most concerned that we work together, that is how we succeed in turbulent times.
